### **Annual Cowboy Hunter Pace Entry Form**

Teams of 2-3 riders ride marked trails of varied terrain, approximately 5 miles in length.

The optimal time is based on completing all (judged and non-judged) obstacles.

#### **Judged Obstacles:**

Judged obstacles are marked. Riders must give the judge their number. One rider from each team must complete each obstacle within 2 minutes in order to count as completed.

Teams may spend no more that 2 minutes at each obstacle. All obstacles are optional and have go-rounds.

## Hunter Pace Etiquette

- Be courteous, ride safely and be respectful of others.
- Maintain a safe distance from other horses at all times.
- Please respect the WALK signs.
- Please walk if you see riders trying to complete an obstacle.
- If passing a team oncoming or from behind, please walk, exercise safety, caution and courtesy.
- Most of all, have fun and enjoy a small taste of what our facility has to offer.

There are two short areas with oncoming traffic: #1 is marked with WALK signs, #2 is the water crossing.

### Cowboy Hunter Pace Rules, Scoring and Prizes

- Greg Eliel Horsemanship will set an optimal time for the completion of the 5 mile course. \*\*\*\* Please note this course includes fields, woods, hills and a mandatory water crossing.
- The optimal time will be set by using a combination of walk, trot, canter, simulating a true fox hunt and completion of **all** (judged and non-judged) cowboy obstacles.
- There are 5 judged obstacles. There are judges posted at each one that will direct riders.
- Scoring: Winners will be determined by teams that successfully complete the most obstacles and then are closest to the pre-set optimal time.
- At least one member of each team must complete the judged obstacle in 2 minutes or less in order to receive the bonus.
- Teams may spend no more than 3 minutes total on any one obstacle. Please do not hold up other teams by spending more than 3 minutes at any one obstacle.
- Ribbons will be awarded to teams for 1st-6th place. Ribbons can be picked up or mailed to you.
- All obstacles and jumps are optional.
- Please stay on the marked course.
- Greg Eliel HLL owners, volunteers or judges reserve the right to dismiss teams or individuals for rule violations or bad behavior.
